Seeking a dynamic professional to lead the collaborative development of wood innovation in the Cariboo region!

Introducing an exciting opportunity for a local professional with deep understanding of the region: to engage local communities and establish a collaborative, sustainable way forward for wood manufacturing and high-value fibre usage.

Our local wood manufacturing community and Indigenous communities are rich with talent, knowledge, and experience in wood innovation. The Project will engage diverse perspectives and amplify regional voices to build a shared, long-term vision and strategic plan for wood manufacturing in the Cariboo region. Using input from regional collaborators, the proponent will establish a wood innovation training hub to accelerate regional wood innovation. The hub will offer local training opportunities, lift and celebrate wood innovators, and support an interconnected community of value-added producers.

#### Introduction

The Fraser Basin Council (FBC) is a charitable non-profit society that brings people together to advance sustainability solutions and practices in British Columbia. Our vision is for "Social well-being supported by a vibrant economy and sustained by a healthy environment."

The Province of BC, through the Rural Economic Diversification and Infrastructure Program (REDIP) – Forest Impact Transition stream, is supporting the establishment of the Cariboo Wood Innovation Training Hub (CWITH).

The Cariboo Wood Innovation Training Hub will serve as a centre for advancing local value-added wood manufacturing by providing labour force development pathways and supporting collaborative, regional action in diversifying the local forest economy. With support from REDIP, the FBC is seeking a contractor for a 2-year period who will further engage with community and stakeholders, produce data and research, liaise with project partners, and develop a sustainable plan and structure for CWITH.

Through this request for proposals (RFP), FBC seeks a qualified contractor with the experience and skills to deliver on the scope of work outlined below.

#### **Project Background**

Like other regions throughout BC, the Cariboo region faces challenges related to fluctuations in the resource economy, with active engagement for the past decade in preparing local residents and the labour force for anticipated changes within the forest sector. As traditional employers confront the impacts of available fibre, it is critical that skilled labour also adjust to new potentials and opportunities.

The Cariboo region and Williams Lake as a hub community are uniquely positioned to capitalize on wood innovation, with established timber and log home builders, educational institutions, and Indigenous entities active in pursuing value-added wood manufacturing. There is interest and commitment from these multiple sectors to develop a hub for showcasing and supporting wood innovation within a collaborative and inclusive process and to bridge the gap between traditional wood production and a higher quality, value-added future.

Starting in July of 2021, based on growing regional interest, a group of leaders in forestry, education and value-added wood industries formed an Advisory Committee and began to meet

regularly to discuss the development of a joint venture in sustainable wood innovation in the Cariboo. Fraser Basin Council (FBC) has since been engaged to support the Project as a neutral facilitator and strategic convener.

The Project builds on the draft business case developed by the CWITH Advisory Committee, in collaboration with the City of Williams Lake, the Cariboo Regional District, and the UBC Alex Fraser Research Forest, all partners on the Project.

#### Scope of work

Fraser Basin Council is seeking a contractor who will take on the role of engagement lead, facilitator, and process design lead for the CWITH initiative - fostering collaboration across a diversity of perspectives and prioritizing collaborative regional values in promoting value-added wood manufacturing.

The Contractor will focus on the following key project deliverables:

- Coordinate project planning and process design
- Lead Indigenous engagement
- Lead stakeholder and community engagement
- Provide mentorship to Indigenous project management trainee
- Re-establish Advisory Committee
- Compile research data and provide written report
- Develop sustainable strategic plan and structure for CWITH
- Launch workshop series (yr 2)
- Trial value-added wood project/training opportunity (yr 2)

# OPPORTUNITY FOR MENTORSHIP:

In collaboration with CCATEC, the project workplan includes the hiring of an Indigenous Trainee in Project Management, to work alongside the Contractor and learn hands-on project management skills in a 20-week training term.

#### **Qualifications and Experience**

Fraser Basin Council is seeking a dynamic professional who has a deep understanding of the region, the operators and local Indigenous and non-Indigenous communities, to connect and accelerate the establishment of an interconnected community of value-added producers. This professional may have an existing consulting business or will have the experience and background necessary to work as an independent contractor on this exciting start-up opportunity.

The proponent must demonstrate ability to deliver impactful results, with a blend of technical expertise and leadership acumen, with significant experience and high competency in:

- *Project Management* efficiently planning, executing and overseeing complex projects through to completion, while adhering to timelines, budgets and quality standards
- Facilitation and Engagement facilitating multi-stakeholder processes, setting and maintaining safe spaces for all voices to be heard while promoting collaborative processes
- Communications effective and inclusive verbal and written communications across a broad range of audiences including various orders of government, business, community, and stakeholder organizations

#### **Proposal Process**

Proposals should include the following:

- description of your proposed approach and methodology for the CWITH project management
- description of your previous project management, facilitation, and community engagement experience
- proposed approach for providing mentorship training within the Indigenous project management training component
- references provide 2 references for similar experience (client contact information), and/or samples of current or previous related work

#### **Budget**

Proposals up to \$90,000/yr will be considered.

The proposal should include a budget breakdown that identifies the tasks, proposed hours, and budget items for:

- a. Project planning and process design
- b. Meeting preparation and facilitation services
- c. Data collection, research, and development of strategic and financial plans

#### Note:

- -Travel costs for in-person meetings throughout the Cariboo region will be covered through separate, additional travel funds
- -The Indigenous project management trainee position will be funded through separate, additional training funds
- -The Project timeline is set for a 2-year term, starting June 2024 and ending March 2026.

#### **Evaluation Criteria and Scoring**

Proposals will be reviewed by the Fraser Basin Council, and will be evaluated based on the following criteria:

- Qualifications and relevant experience of the contractor, as identified in the qualifications section above
- Proposed approach/methodology
- Timeframe and commitments to proposed schedule
- Overall cost and value for budget

#### Appendix A – Additional Project Information

#### **Intended Project Outcomes**

- Engagement with local Indigenous governments and entities, local and regional governments, and stakeholders active in forestry, value-added wood sector, education/training for collaborative approach
- Completion of research activities to assess a) current value-added manufacturers/training opportunities in region b) current forest product/wood manufacturers in region c) value added opportunities summary
- A path forward: a focus on higher value log usage & collaborative hub for research and training activities
- Job creation and skills training in value-added wood manufacturing, incl. retraining workers displaced from forestry jobs
- Increased viability of business for value-added wood manufacturers, and a network of local expert trainers in wood innovation & craftsmanship
- A long-term self-sustaining structure for CWITH, creating new ideas for value-added opportunities
- Improved collaboration between educational institutions, regional governments, and the value-added wood sector
- Community positioned to attract investment in forestry, education and construction industries, advancing value-added wood manufacturing sector in Cariboo region

#### Appendix B – Breakdown of Key Deliverables

#### YEAR 1

- 1. Project Planning and Process Design Develop Project Workplan (objectives, scope, work breakdown structure, roles/responsibilities, risk plan, budget plan, communication plan) Identify key actionable steps for establishment and sustainable operation of CWITH, incl. operational costs/funding Convene meetings related to engagement, advisory committee, develop workshop/training opportunities for actualizing value-added potential within applicable context; create space for idea generation/dialogue
- 2. Provide mentorship to Indigenous project management trainee work alongside trainee, providing direction and hands-on training in comprehensive project management skills, including project planning and implementation, and communications and community engagement
- 3. Indigenous Engagement Build on existing relationships to engage Indigenous entities active in forestry, value-added wood manufacturing, training/employment, collaboratively identify priorities and synergies with current operations/aspirations
- 4. Stakeholder/Community Engagement Liaise with project partners to engage stakeholders/broader community in coordinating new path forward for value-added wood sector, collecting input through surveys, meetings, effective communication methods -Support forest licensees, tenure holders, private landowners to match fibre supply to value-added opportunities
- 5. Re-establish Advisory Committee Connect with existing advisory committee, grow membership, establish meeting schedule/frequency, field tour information sharing/networking schedule
- **6. Compile Research Data** Complete up-to-date scan of regional value-added manufacturing entities, existing educational opportunities for wood manufacturing

training, identify gaps/opportunities, priority CWITH focus areas

YEAR 2

- 7. Develop sustainable Strategic Plan and Structure for CWITH Building on data collected/Indigenous/community engagement, complete strategic plan, complete financial sustainability plan, set up legal structure for CWITH, branding, etc
- **8.** Launch workshop series based on interests identified in Year 1 activities Plan/host introductory workshop series based on engagement and identified priority areas
- 9. Continue Stakeholder/Community Engagement and ongoing Advisory Committee support - Host regular meetings/field tours, industry networking opportunities - Send out newsletter updates to partners, stakeholders, community - Host collaborative site/bus tours to visit value-added wood manufacturing sites in region
- **10. Trial value-added wood project/training opportunity,** as identified in Year1 Secure materials Source additional funding partners

The first two years of Project are intended to establish a framework for successful project implementation in following years, alongside a long-term self-sufficient structure for CWITH.
