PROJECT DESCRIPTION

Given the high cost of electricity in the Gwa'sala-'Nakwaxda'xw Nation, it was decided to develop a Community Energy Plan and to explore the various technologies that could assist the nation and its members to find economies in the cost of hydro by using alternative, green technologies. To that end two representatives from the Gwa'sala-'Nakwaxda'xw Band Office traveled to Skidegate, Haida Gwaii, to consult with representatives on their approach to the Community Energy Plan and how to use alternate technologies to reduce the cost of electricity in the community and encourage self-sufficiency in providing the energy the community needs, and eliminate their dependency on diesel power generation.

Upon arrival to Skidegate, Roger Nopper (Band Manager) and Leo Lawson (Construction Manager) met with Council representative, Trent Moraes, to discuss the history, approach, installation and operations of air source heat pumps, solar panels and improvements to housing and office structures to reduce the need for electricity generated through diesel generators. There was also a short video presentation on the installation of the air source heat pumps and solar panels. Trent then took Roger and Leo on a tour of the community, highlighting the successes. It was a highly informational meeting and both representatives were impressed by what they saw.
