1. Introductions, Agenda, Objectives

Mike Simpson welcomed everyone; territory was acknowledged. Introductions were made. The agenda was approved as presented.

2. Previous Meeting Summary

The meeting summary from May 10, 2021, was approved.

3. Wildfire Season 2021

What did we learn:

Common themes

- Staffing level/capacity challenges
- Timelines fuel was dry and fast (would prefer to be more prepared than less)
- Learning from Logan Lake (FireSmart poster child)
- Using fire department crews, fire brigades and local resources
- Communications
- Equipment who has it where at least getting signed up in advance
- More flexibility on prescribed burning, venting indices
- Water bars (better understanding of access and egress)

Questions and Discussion:

Blackpool VFD (TNRD)

Mike - Biggest takeaway was timeline and the impact on responders and communities – more time needed to get resources out and in place. Would prefer to front load and stand them down instead of trying to catch up.

Wells Gray Community Forest

George – there is a drive now to increase fuel management around Clearwater and the community forest interface area. Other funding sources could be used to fund summer students (high school) to pile sticks and prune. Almost 70ha done in the community forest.

Community forest can help with the water bar inventory, we can drive the roads and make an inventory within interface areas. We can utilize the forestry working group.

BC Wildfire Service

Richard – many opportunities for the fire department and locals to get into the prep side, which was successful. It needs to happen in the build up to the fire season, as opposed to in the fire season where resources are tied up.

challenges around backcountry closures – benefits too (eyes out & reporting). Restricting backcountry use uses a lot of resources (keeping people out/keeping people safe). Need to be assessed on a case by case basis. Balancing the considerations for public, land base and communities are part of that.

MFLNRORD

Marina – need to spend more time up front to understand who/when/how to communicate. People are not sticking to the plan. Maybe mock runs through the winter?

Secondly having equipment under contract needs to happen now, not when the fire is coming over the hill. It would be useful to have a component of people that know how to organize and manage equipment on the landscape.

BCTS

Tyson – not a lot of community interface area. Still active in broadcast burning for post-harvest, mostly in wet belt. Policy/political challenges allocating resources between BCTS and MFLNRORD. Weekly update to Kamloops office lists active operations, and equipment so they know what they have and where.

Search and Rescue (S&R)

Tyson - prep before the season to ensure that they were ready. Remote generator and substation to provide services if the community was cut of from some resources. Active roster to EMBC of individuals available locally and which were available to go outside to assist in outside communities. Connect S&R into communications

TNRD

Sherri – debrief of EOC from this season in 2 weeks. Kevin's report, available on TNRD website from October 21 meeting, found here. Challenges – trying to control access – we ran out of bodies – S&R and RCMP were exhausted. Alerts and Orders were delivered via Voyent and Facebook. Security challenges, trying to keep people out, both people that live there and people that know no one is living there. Carol – local contractors that were not registered that were not getting called. Can we make a list of every contractor whether they are available or not?

Who would we talk to about water bars and how to address them for access and egress?

Wells Gray Provincial Park

Vladi – Regional and provincial debrief (regional third party, no results yet). Challenge – Rangers in ICS, different zone person ever week, communication was a challenge. Also had staffing issues and had rangers come from other regions. No other work got done so it was tough.

How do we maximize this round table? What's Underway:

BlackPool VFD (TNRD)

Mike - Trucks are all interchangeable, funding from BC hydro an additional tank placed at Star Lake school. Working to get dry hydrants — water from the river to load the trucks at Little Fort because there is no active well. Missed the federal infrastructure grant for solar agitators. Hope to get all the members at all the halls to be certified in structural. Structural assessments done allows us to prep for this year and gives us the added ability to review as we are going in to see if there are any changes and gives homeowners opportunities to FireSmart their properties. Will be adding to structural protection arsenal and trying to get equipment leveled up to the point where we are confident we can respond to mutual aid partners. Turned down four deployments because we couldn't go beneath a minimum staff level

BCWS

Richard – After action attention being paid to where we can improve, where we can change and adjust for next year.

Michael – 6 efficacy studies in province, 5 in Kamloops fire center. All funding streams come to an end this year – not expecting much change. Will get results from the studies

George – link with some fire science people (permanent sample plots) try to bring in Lori Daniels (UBC). We are on the edge of dry so there is probably stuff to learn.

Julie sharing a map – found <u>here</u>. Continuing Clearwater CWPP and on track to complete 40 ha. 40 ha complete last year. Would like to expand into prescribed burning.

Wells Gray Provincial Park

Vladi – one wildfire reduction plan did not happen, in wells gray. Don't know of anything specific planned. Will put George in touch with Todd regarding field data collection for Sphats creek

BCTS

Tyson – very little in interface area with BCTS. Looking at 40 – 50-year-old stands for commercial thinning opportunities which could have win-win for wildfire risk reduction.

West Fraser

Rob – moving into Clearwater area significantly next season, next summer moving forward. Ensuring roads are upgraded and maintained.
