RESIDENT WOOD STOVE SURVEY

PURPOSE:


- To guide the design and delivery of the Kamloops Wood Stove Exchange Program
- To approximate the number of wood burning appliances that could be replaced
- To gauge the level of interest in an incentive-based exchange program

METHOD:

- Survey notice (and incentive) sent to property owners c/o May Utility Statements
- Distributed to approximately 20,000 property owners
- Completed surveys submitted online (530) and in-person paper (379)
- Total of 900+ responses (approx. 4.5% response rate)




Responses when asked what type of wood burning appliance they have




- Over half of respondents with a wood burning appliance have an open-hearth wood fireplace
- Other common types include wood fireplace insert and wood stoves.



Responses when asked if wood burning appliances provide the main heating source




 Majority of respondents with wood burning appliances have an alternative source that provides the primary heat. Responses when asked if the wood burning appliance owned is EPA-Certified




- Almost half of respondents who have wood burning appliance were unsure.
- Out of those who knew, **43%** have non EPA-Certified appliances.



- Of the respondents who have wood burning appliances, over half (51%) would be interested in an exchange program.
- Of those that know their appliance is non EPA-certified, 20% would be interested in an exchange program



Responses when asked the optimal choice to replace their current wood-burning appliances










Responses when asked if wood burning smoke is an issue in their neighbourhood



 Majority of respondents (85%) stated they don't believe smoke from wood burning appliances is an issue in their neighbourhood. 53% of people who don't think wood smoke is an issue, own a wood burning appliance



Available Incentives

City of Kamloops	\$250 for wood to EPA-wood exchange (includes permit fee)\$400 for a pellet stove, an electric heat pump, or natural gas						
FortisBC	\$300 for a natural gas appliance						
BC Hydro	\$800 for a heat pump						

Incentive Bundling Options

Natural Gas Stove	\$1,100 (\$400 from the Province, \$400 from the City of Kamloops, \$300 from FortisBC)
