Shuswap Water Monitoring Group

- Bi-annual meeting held February 27th
 - Staff from 13 different organizations participated
- Reviewed 2024 watershed monitoring plans by all parties
- Committee heard SWC updates from staff
 - Referendum results
 - Water Quality Grant Program
 - Progress on wetland strategy



Shuswap Water Protection Advisory Committee

- Bi-annual meeting held February 28th
 - Representatives from six organizations and the agriculture sector participated
- Purpose of meeting was to review Water Quality Grant Program applications
 - 8 applications were reviewed in detail and discussed
 - Six projects worth a total ask of \$59,960 SWC funds are recommended (later agenda item)
 - Two projects not recommended for funding due to application being incomplete and not meeting grant program criteria



Water Quality Grant Program

2023 Funded Projects

- Rivershore Nursery fertilizer and irrigation reduction. Project complete.
- Crystal Lake Ranch livestock control fencing along Eagle River. Project complete.
- Shuswap Organics cover crops and no-till agriculture. Project complete.
- Fresh Valley Farms automated pastured livestock management. Project complete.
- Iron Horse Ranch fencing and off-stream livestock watering. Project complete.



Water Quality Grant Program

2024 Intake

- Grant Program was open for applications December 1st 2023 – January 31st 2024
 - Grant Program Guide to assist applicants
 - Staff spoke one-on-one with interested applicants, provided support and guidance
 - Applications received through online portal
- Advertised across the Shuswap watershed
 - Newspapers, social media, word of mouth, agriculture supply stores, EFP advisors
- Informative webinar held on January 10th

GRANT FUNDING FOR FARMS

Up to \$65,000 grant funding is available from the **Shuswap Watershed Council** in 2024 to assist farmers, landowners and other stewards in the Shuswap watershed with projects to protect or improve water quality.

Phase 2 Wetland Strategy

- Grant application submitted in fall of 2023 to Environment and Climate Change Canada's Fraser River Freshwater Ecosystem Initiative.
- Application was successful, \$40,000 awarded for Phase 2
- Request for Expressions of Interest received 5 proposals
- Associated Environmental Consultants Inc. were awarded contract
- Deliverables refine GIS database, gap analysis + quality assurance and data validation, literature review and discussion paper, two-hour workshop with SWC Wetland Committee, wetland prioritization and classification and Phase 2 Wetland Strategy report
- Work must be complete by March 31, 2024



Zebra & Quagga Mussel Prevention

- Early detection monitoring for ZQM in 2023 found no invasive mussels in Shuswap or BC
- Staff participated in the inaugural 'Okanagan-Interior Working Group on Invasive Mussels' meeting on March 8th in Kelowna hosted by the OBWB
 - ~ 80 90 people attended
 - Informative presentations by OBWB, Province of BC
 - Workshop to discuss and provide input to prevention, containment and management strategies





Zebra & Quagga Mussel Prevention

- Concern over lack of funding for Provincial Invasive Mussel Defence Program
 - Rumoured cut-backs from federal government and industry sponsors
 - February 14th announcement by DFO re: \$540,000 to Habitat Conservation Trust Foundation over 2023 – 2025 – early-detection monitoring for ZQM and \$90,000 for two new decontamination trailers for DFO to deploy





Advocacy

- February 22nd letter to four Federal Ministers to ask for immediate, long-term funding to the Province of BC to expand the watercraft inspection station network
 - All entry-points to have an inspection station
 - 24 hours/day, 365 days/year

"Watercraft inspection stations are not open 365 days a year nor are they located at all entry-points to BC, and invasive mussels are known to survive out-of-water for up to 30 days. An infested watercraft could depart Manitoba, Ontario, Idaho or another jurisdiction today and be in BC, unchecked, tomorrow."



Communications

- Media releases:
 - December 20th: More funding available from Shuswap Watershed Council for water quality protection; informative webinar offered in January
 - February 22nd: Shuswap Watershed Council urging federal government to provide more funding for watercraft inspection to prevent spread of mussels



Communications

Communications from the SWC during the CSRD referendum period:

- Key collateral: SWC Annual Highlights Report, FAQ document, articles on the SWC website
 - Staff shared communiques with staff at Elections BC in advance of the referendum
 - SWC registered under Local Election Campaign Financing Act (LECFA)
- Key messages: SWC role as advocate, collaborator, educator, support for monitoring and research
- Method: social media, newspaper advertisements, direct e-mail
 - Two paid ads in Black Press
 - Paid ads and articles in Shuswap Scoop and Kicker
 - Four paid ads on social media plus organic (unpaid) posts



Administration

- Work plans and budgets developed in January February
 - Scenarios A, B and C reflect different revenues
- Amendment to Contribution Agreement with funders under way
- Fund development: staff applied for grant funding from Transport Canada Boating Safety Contribution Program in October. Request of \$24,391 would support safe boating and swimming campaigns in 2024. Awaiting confirmation.
